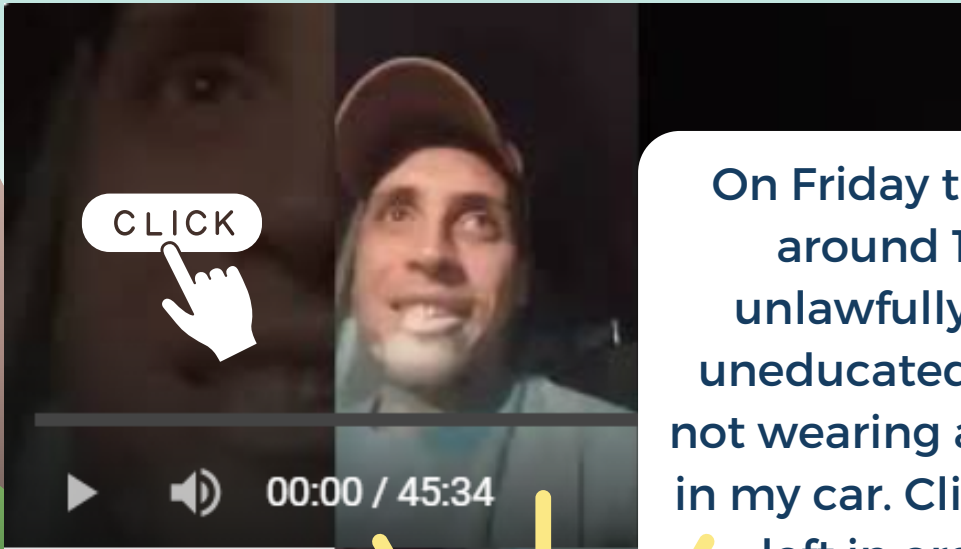

# THE FULL STORY

FRIDAY 18TH JUNE 2021

**WHERE?** Umchali, Salt Rock road just after Tiffany's Mall in South Africa, KZN, Dolphin Coast, two off ramps away from Ballito.

**WHEN?** It happened about 4pm i was on my way to go refill my water tanks at Oasis water in Tiffany's Mall. i drove past the road block on my way there and on my way back they happened to stop me.

**WHAT?** A traffic police officer stopped me on the side of the road, he asked me for all the relevant information which i politely gave him, after i had complied with his instructions he basically told me that i could leave;

Before i left i took the opportunity to converse with the officer in order to rightfully test his knowledge of law in order to see if he knew that he was not allowed to pull me over or request anything from me until he first provided a verified claim of trespass. i then proceeded to tell him that i am not a citizen, he kept trying to clarify whether i am a citizen or not after i said that, it was like he was planning to deport me. i proceeded to explain that yes i am not a citizen but yes i was born on South African soil and lived here all my life. i also then proceeded to explain to him that the roads are public and that anyone has the right to use them and that i was just a traveler travelling in a car and that they cannot administrate me because the only thing that the service corporation known as the Republic of South Africa can administrate are motor vehicles, drivers, legal persons and citizens, i am neither, i am instead a traveler travelling in a car instead of a motor vehicle and i am a living man not a citizen or a legal person and therefor they cannot administrate me or my property.

At this point the police officer was getting very frustrated with the fact that i seemed to know more about law then he did, and little did i know it appeared that he no longer wished to allow me to go, instead he wanted to arrest me for not wearing a mask whilst alone in my car.



## AND THEN WHAT?

AT THIS POINT IT BECAME CLEAR THAT I

**WHY???** Well it just so happens that i run a global organization that deals within law, technology and sustainability, but our main, main, main focus is LAW.

We have multiple case studies where our knowledge has helped people around the world win multiple court cases, thanks to us teaching them how to enter the court as a living man or women, instead of entering it as a citizen or legal person.

**SO..** At this point i knew i had to verbally serve these police officers an honorable notice of liability. i got out of my car facing a large group of policemen and women and i proceeded to service them notice:

i had said the following to them;

Unless you can provide a verified claim of trespass from another living man against i the living man claiming i have caused harm loss or injury towards them,

Claim or prove that i am property, which i explained to them that seeing as though no one can claim i property, then who can administrate me without right [seeing as though the Republic or any man or women in the public did not create or own me, no one can administrate me without that right].

or whether a obligation [contract] between i the living man and the service corporation known as the Republic of South Africa exists that gives the Republic right to jurisdiction over i the living man.

I then told them that if they trespass against me that each of the men and women working there on behalf of The Republic would be liable for 1,500,000.00 rand for the first trespass and 3,000,000,00 rand per each additional trespass.



# DID IT END THERE?

NO OF COURSE IT DIDN'T END THERE, THANKS TO THE POLICE OFFICERS LACK OF KNOWLEDGE ABOUT LAW THEY HAD MADE ME WAIT AND WAIT AND WAIT IN MY CAR...

**WHY???** Well it turns out that the metro police were far too ignorant or uneducated by the South African Police Department resulting in them having no idea that they had just been served the notice that unless they can answer any of the questions within notice then they would have no right to jurisdiction over i.

Well lucky me because i had later found out that the bylaw officers where in the group that i served a verbal notice to on that faithful day.

i proceeded to ask all police officers for their name and identification, which none of them provided, one of the bylaw officers pointed to his jacket saying "here is my name here", but he did not fulfill my rightful request.

**OKAY...** so at this point the bylaw officers have showed up as they are now the ones who are questioning me after i served them all a notice liability.

**WHY???** Well i had been handcuffed for about an hour straight now both hands behind my back sitting in my car, i got up out of the car after my arms were so sore, the police looked at me and did nothing, i proceeded to stand outside of the car.

I took this time to start educating the police officers that were standing around my car in the parking lot and i had educated them on how screwed they were and that they really could of not arrested anyone worse then me, someone who inextricably knows his god given rights and is not afraid to sit in court and state inarguable facts before a judge ultimately resulting in me asking the same questions i asked the police officers. And having those questions additionally unanswered by a judge will prove in court yet again that The Republic of South Africa just like any other service corporation only has jurisdiction over legal persons, citizens and has no right to have jurisdiction over living [wo]man.

AT THIS POINT THE OFFICER HAD NOW TAKEN ME TO THE CAPTAINS OFFICE BUT KEPT ME OUTSIDE OF THE CAPTAINS OFFICE TO ASK ME.

## WHAT?

Well he told me he was being the nice guy and that he was gonna tell me what would go down but asked if my camera could hear it, i put my phone on the ground while i was live streaming to my YouTube channel.

i started live streaming the whole event as soon as my one hand became free of the handcuffs after the officer had uncuffed me to the steering wheel of my car.

## THE

## NERVE..

Once my phone was on the ground he said to me that he was just gonna take me inside for them to give me a misdemeanor charge, i picked up my phone carried on the live stream, walked into the captains office where all the cops were including the two bylaw officers.

My live stream was interrupted just after i entered the captains office. They wanted me to sign a written notice to appear in court on the 19th of July 2021, i told them that there was no ways that i was going to sign anything that they gave me as it is my god given right not to, they proceeded to all call me stupid and told me that if i didn't sign it that i would have to stay in jail for the next 30 days until my court date. i then held out my camera and attempted to verbally declare that i was signing it under duress and that is exactly when the one bylaw officer jumped towards me grabbing my phone in my hands.

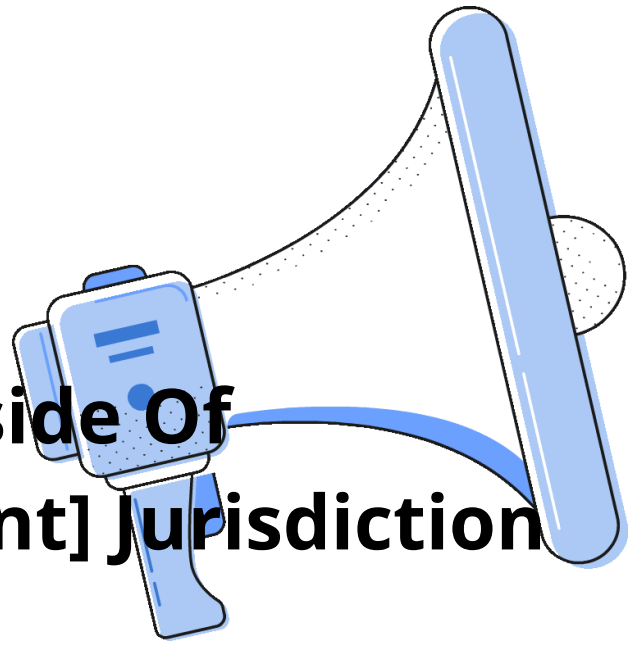
## **Your [Governments] Have Trespassed Against You!**

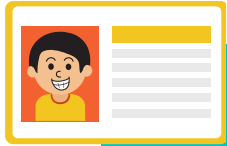


Do not confuse this for law because it is not this is simply the world of corporate legal policies that only apply to the incorporated and not the living man or women.

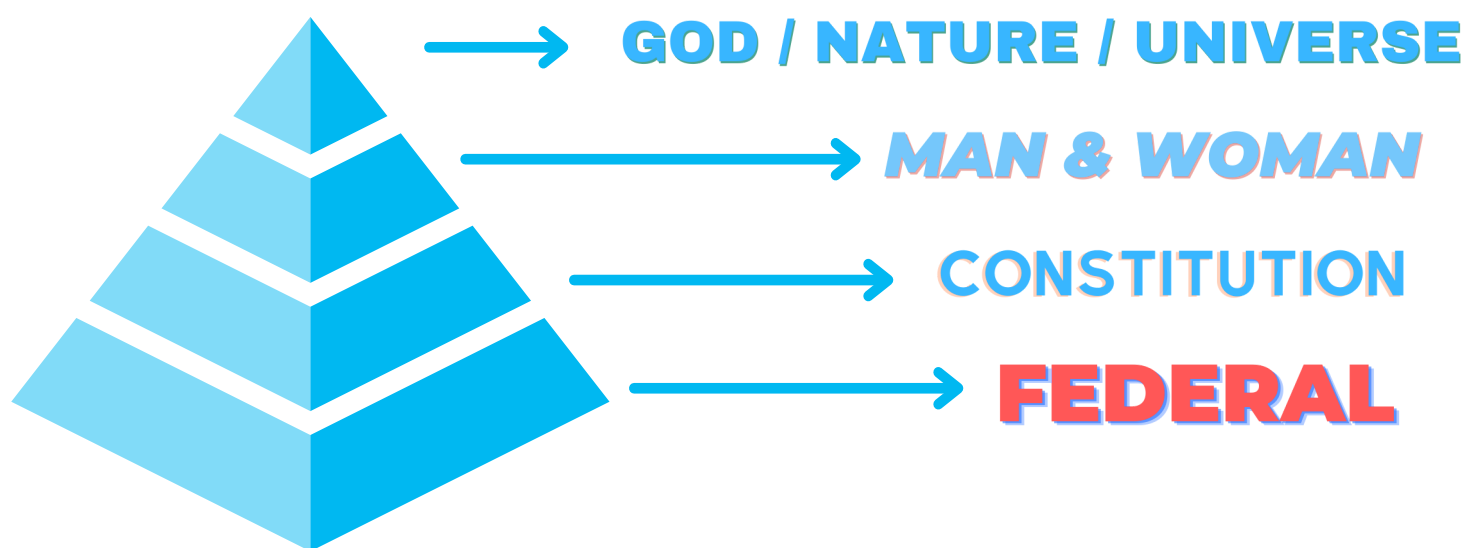

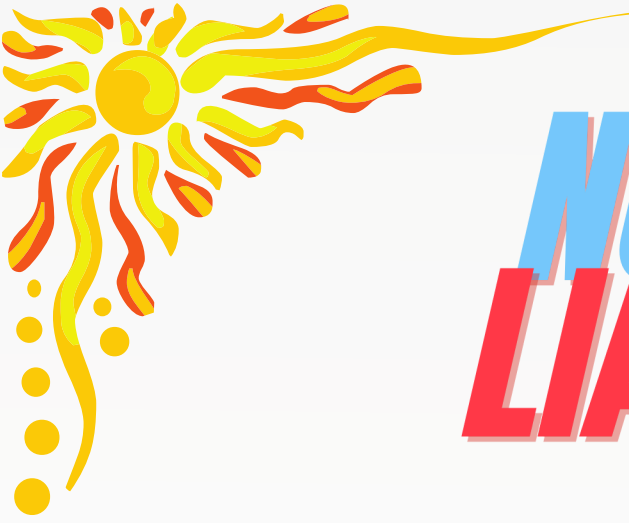

# ***NO JURISDICTION***

If the service corporation [government] has no contract with i the living [wo]man and cannot claim i as property [prove i am someone or something's property] and that if they cannot prove that they can administrate [control / own] property [your body / land / business / car / children / animals] without right then that means each service corporation [government] holds no power or right to jurisdiction [control or own] over us...

## Application of Act

2. The provisions of this Act shall apply to all South African citizens, whether in the Republic or outside the Republic, including persons who are not South African citizens but who sojourn permanently or temporarily in the Republic,

# ***SOUTH AFRICAN BIRTH CERTIFICATE ACT***

# *Application of Act*



THE PROVISIONS OF THIS ACT SHALL APPLY TO ALL SOUTH AFRICAN **CITIZENS**, WHETHER IN THE REPUBLIC OR OUTSIDE THE REPUBLIC, INCLUDING **PERSONS** WHO ARE NOT SOUTH AFRICAN **CITIZENS** BUT WHO SOJOURN PERMANENTLY OR TEMPORARILY IN THE REPUBLIC,

*15. for whatever purpose.*

As you can see the South African constitution only applies to CITIZENS and PERSONS and it does not apply to the living man or women which it fails to mention.

The above excerpt is from the South African constitution where nowhere in the document does it mention anything about the living man or women.
